The Crime division of a police station shall investigate important cases in a continuous manner which will improve the quality of investigation. They will be closely supervised by the SDPOs/Inspector SHOs. A team concept of investigation will be followed by the Crime Division which will, therefore, bring in "part investigation" by various members of the team as envisaged in law (Sections 157, Sections 165 Cr.PC and 1971 Hon'ble Supreme Court judgement).

The members of Crime division cannot be changed unilaterally by the Inspectors and SDPOs. The members of the Crime Division in normal circumstances shall not be engaged in any other Police Station duty. However, the rotation duties like Sentry Duty, GD in-charge and Night Patrol only can be given to them. However, the Inspector SHO must keep in mind that the crime investigation in the Police Station is extremely crucial and more time should be spared for such investigation so that better results will be achieved

The Inspector SHO is vested with the discretion to entrust either part/whole investigation to any of the competent subordinate officer in exceptional circumstances.
